Harrison, Walter M. (1888–1961). Papers, 1915–1961. 10 feet.

Journalist. Personal correspondence (1930–1961); military papers (1918–1959); political campaign materials (1949–1959); biographical materials (1915–1961); business correspondence (1931–1961); Pulitzer Prize Board materials (1938–1942); Will Rogers Memorial Commission papers (1938–1961); National Cowboy Hall of Fame files (1955); and Civil War Centennial Commission materials (1953–1961), all reflecting Harrison's personal affairs and his association with the above organizations while an editor for the *Daily Oklahoman* and the owner of *The North Star*, along with papers (1949–1959) regarding his service as a city councilman for Oklahoma City, Oklahoma.
